

## STATEMENT OF

A: O.K.. No, I don't think you have to have goals for it, it's just too (interrupted).

Q: That's not what I'm talking about.

A: I believe that people are important.

Q: Okay. That's fair. Now, (interrupted).

A: My work is not the most important thing. Um, (interrupted).

Q: But there's (interrupted).

A: I mean that's why even though I learned years and years ago that things weren't working out at home, you know, it's like didn't want to hurt people (inaudible).

Q: Do what you can to make it work.

A: Yes. Yes.

Q: Okay. (Interrupted).

A: Now, it, now (interrupted).

Q: That's commitment.

A: I'm not sure what, what you, what you call it. I mean, you can ask him (inaudible) as far being committed to each other in a hard life way. I mean, that wasn't there for a long time. But, probably through people and (interrupted).

Q: But for the kids you guys stuck it out.

A: I tried to for a long time. Now, in that position though you're not really free to go beyond a certain point with other people.

Q: Okay.

A: But, you may enjoy other peoples company, or spend time with them, or spend (inaudible). And...I'm sure, If I had a chance... number of people think things (inaudible) people all the time.

Q: Okay. With that said, how can you tell me you'd be okay with this guy being with both of you at the same time?

A: Well, if that was to be the case and everybody was in a position to do that, and okay with it (interrupted).

Q: That's not what I asked.

A: No. Because we weren't... I wasn't quite in a position to be that... I mean, not yet.

Q: Why weren't you in a position to do that?

A: 'Cause I felt it was inappropriate to...finish what we were in the process of doing something (inaudible).

Q: So, you wanted to wait until you were divorced before starting a relationship.

A: Well, doesn't that make sense.

Q: Some people believe in that stuff. Some people are like, "We're separated, we're getting divorced oh, well let's go for it. Time to play."

A: Well, knowing that's it's coming, yes some would say, "Oh well". I mean, it's probably natural to think about what you might, what actually you have and I wouldn't say that getting tied immediately in another exclusive relationship is necessary what would happen. And I don't, it, I don't know. I wasn't, I didn't know.

Q: Alright. So, that's what you wanted to find out from Colleen.

A: What she believes there status was.

Q: And she(interrupted).

A: She (inaudible).

Q: That was so important you had to come to Orlando from Houston.

A: And I thought it was important that she knew, I wanted her to have the same awareness, I guess, for my potential, or whatever.

Q: Okay. .

A: And I just, she has, I'm, I'm not sure (interrupted).

Q: So, why did you, where did you get the pepper spray from?

A: A store.

Q: Okay. And in Orlando, or in Houston?

A: Between.

Q: Why did you bring the pellet gun?

A: I didn't have any of that stuff out. I just (interrupted).

Q: (Inaudible) why did you bring the pellet gun? It's a very simple question.

A: [REDACTED]

Q: Wanted (interrupted).

A: No. I didn't. I just (inaudible). I didn't do any of those things. I had no intention (interrupted).

Q: No. You didn't point the gun at her, but you did bring the gun and you were afraid she wasn't gonna' talk to you. So, if she didn't talk to you were you gonna' kill her?

A: No. [REDACTED] I, it wasn't, I just wanted her to talk to me, and [REDACTED]

Q: I don't understand. She wouldn't what?

A: (No response).

Q: She wouldn't what? You think she wouldn't talk to you?

A: (No response).

Q: I mean (interrupted).

A: I, I, I didn't know if she believed... that...they met each other and thought that was,

they.

Q: So, why the disguise?

A: [REDACTED]

Q: Then you think that disguising yourself up, so she didn't recognize you at all is going to help you get into her car and talk to her.

A: [REDACTED]

Q: Why did you write down the ammo 9 on the list.

A: I didn't write ammo down.

Q: Well, it's your handwriting, ammo 9.

A: I did not write ammo 9. I, I (interrupted).

Q: So, what was that suppose to mean?

A: I don't know.

Q: Okay. Why would you mean to bring three, only three large garbage bags?

A: Well, I have something to put in the trash, in the car.

Q: Three large bags to put trash in the car?

A: it's a lot of trash.

Q: Three?

A: Okay. Five, whatever, I mean it's (interrupted).

Q: Are you living out of your car?

A: No.

Q: Are you dumping feces in the bags, or something?

A: No.

Q: Well! Do see how illogical that statement is?

A: No. I, I, I take, I take trash bags when I travel in the car. That's not illogical.

Q: Okay. Trash bags no, it's not illogical because you have kitchen bags, kitchen trash can size bags. Lawn and garden bags, that's illogical. Do you really go through enough trash, or go through enough garbage that you need three lawn and garden bags.

A: No. They just hold liquid better than grocery bags (interrupted).

Q: How much liquid are you gonna' put in those bags?

A: Well, you have a drink like, like chocolate milk, and you don't finish 'cause it gets warm and you put it in there and you don't want it to leak.

Q: Excuse me for a minute.

A: What?

Q: I thought I had stupid on my head, or something. I mean, really (interrupted).

A: That's all that it's for.

Q: Okay. So, let's put you back in the jury. You're in the jury box and you hear that this person brings three lawn and garden trash bags for, with ties to throw away liquid better.

A: It's just, it's you (inaudible) just all of (inaudible).

Q: And you need three of them for all of that?

A: Is it that important?

Q: It is important, okay because appearance is everything right now.

A: I don't understand.

Q: You've got a pellet gun. You've got this list. You've been thinking about this since, the end of January, January 23<sup>rd</sup> to be exact. You drive all the way from Houston to Orlando. You, it's not that you're gonna' meet her at her house. You come to the airport. What does that look like to you? You're just coming to talk to her?

A: Yes.

Q: Hay, cono (Spanish). The, the damage, here, here's the thing you've already affected the people you're trying to protect.

A: If, if um,...she decided (inaudible) to say (inaudible).

Q: Goes back to it's really not up to her right now, it's the State Attorney's office. You have to convince the State Attorney's office not to press charges.

A: Okay. Well, first, first thing is probably to talk to her.

Q: In a case like this, it carries very little weight.

A: Why?

Q: Because it, it um, it deals with the emotions. It doesn't, it doesn't deal with um, it's not as much logic as it is emotions. Okay. The two of you of a similar interest in a, in another person, and because of that (interrupted).

A: I don't know.

Q: ...interest, you're in here.

A: Right. I don't know what, if, if, if it's a similar interest to what degree, or anything. I don't know that (interrupted).

Q: It doesn't matter what the degree is, it's just the fact you have a similar interest. You're here, and because you're here you're here because you're trying to find out where you stand with an individual, that's considered emotions. Because logic would be for, it's not logical for you to drive all the way from Houston to Orlando just to have a chat with somebody in there car, in the parking lot at the airport, okay. So, because it is involving so much emotion, State Attorney office, State Attorney's office realizes that, and that's why they get the last say in prosecution of the victim. They don't want the victim making these emotionally based decisions, after the incident.

## STATEMENT OF

A: That might be logically (inaudible).

Q: To be honest with you there's no logic in anything that happened tonight.

A: Okay.

Q: Okay? So, let's get back to where's your car?

A: Are you going to tow it?

Q: Well, if it's towed I can guarantee you that it's not gonna' get broken into first. We have a lot of auto burglaries out here.

A: Okay.

Q: Okay? Second, the next thing I'm gonna' ask you, if I have consent to search your car, in which case I'll need the keys to your car.

A: What if I say no?

Q: Then I'll go get (a Search Warrant for your car, and I'll search your car anyways.

A: (Inaudible).

Q: Okay. Um, where's your car?

A: (Inaudible).

Q: We haven't finished that one.

A: I'll (inaudible).

Q: Okay. No. We can't come back (inaudible). Here's what's gonna' happen, you can either tell me where you're car is, or I can search the records of each parking lot through out this airport (interrupted).

A: I'm not, I'm not (interrupted).

Q: ...in which case I'm going to notate how uncooperative you've become.

A: No. I'm not going to do that. I just want, I, I still don't understand what's going to

happen to me?

Q: I (interrupted).

A: It sounds like this is the only place your going to talk with me, then your done with me, and I, I, just (interrupted).

Q: No. (Interrupted).

A: (Inaudible). [REDACTED] I just don't understand, you told me where I'm going.

Q: Huh (meaning what)?

A: I just don't understand (inaudible) and what happens after that.

Q: Okay. I kind of figured this is a quid pro quo so, I've already answered part of your question. I'm waiting for the answer for parts of my question. So, where's your car?

A: Is that my only question?

Q: No. I have more questions to ask you.

A: You're not going to ask me other questions?

Q: No. We're going to deal with this question first. So, where's your car?

A: I feel like the only thing I value, I have left to give you, and if you cannot help me anymore.

Q: Okay. (Interrupted).

A: I, I (interrupted).

Q: Let me, let me explain it this way.

A: Okay.

Q: Okay. I'm not (interrupted).

A: I (interrupted).

Q: Listen, now you're, now don't start thinking like you know what I'm gonna' say.

A: Okay.

Q: I am not the type of man that is gonna' tell you somethin', and then not follow through. I'm definitely not like the man that is just gonna' string you along for a ride. Now, the thing is this, I'm not gonna' lie to you to control this interview either.

A: Okay. Fine. It's not about control.

Q: It is about control. You've been controlling a lot because you have, and here's the thing this is the type of individual I see you as, tell me if I'm wrong. You are very particular about what you say and how you say it. You deal mostly with logic. If it doesn't make logic, if you can't make logic out of it, it doesn't count. And the problem is you can't make logic out of your actions either, okay. Now, you're very much a thinker. (Tape 3) So, (inaudible).

A: (Inaudible)?

Q: No. It will probably be another 15, 20 minutes. But in the mean time we can be going out to the car.

A: (Inaudible)?

Q: Mm, huh (meaning yes).

A: Schedules, schedules, and schedules.

Q: Okay. Do you have the keys on you, or they, they take the keys from you?

A: (Inaudible).

Q: (Inaudible).

A: (Inaudible). Would it be possible to wait until they answer before we go?

Q: (Inaudible) right now. My sergeants kind of tired of me dragging this out.

A: Because you already know the answer?

Q: The answer to?

A: Phone call.

Q: No. I would tell you if I knew the answer to the phone call. I can tell you what I think the answer is gonna' be, but we're gonna' have to notify him.

A: Because?

Q: It's a felony and because you work for NASA.

A: Yes. (Inaudible) that we're going, I have (inaudible).

Q: So, you're not gonna' take me to your car 'cause we need to it do now.

A: Okay. Just let me get that answer, and then we can go.

Q: No. I need to go now, either that or I need to, to check and see how far along we are in researching the tags. 'Cause if I gotta' go find out where we are in researching the tags, we're done.

A: (Inaudible).

Q: (Inaudible) pay for it. I'll find out where your car is, I'll get the search warrant, I'll tow it. It's just gonna' delay things, drag things out. Question is do you want to hurry up and start moving on, or do you want to drag this out?

A: (Inaudible). I have to (inaudible).

Q: Well, then if you hand me the paper, we go to the car. I, you're, you're giving me consent to go through the car, we can go to the car right now, okay. Once I've done that come back here, I do the paper work, and we're on way to the county jail.

A: Can I make a call?

Q: When you get to the county jail.

A: I am there for (meaning how long)?

Q: Anywhere from eight to seventy two hours just depends on how busy they are.

A: What if they find out while we're gone will, they call you?

Q: Yes. I have a radio, I have a telephone, I have a pager, anybody can get a hold of me at any time.

A: Um. Can we change the charges.

Q: No. It is what it is. I'm not changing it. Even if you tell me to go pound sand, you're not taking me to the car the car, you're not giving me consent(to search the car), same charge. I don't, I don't operate that way.

A: Why did you (inaudible)?

Q: Because I haven't talked to you about it. I want to see what you have to say about it. I think it looks quite hinky to be honest.

A: Did you understand why I said,(inaudible) how (inaudible)?

Q: Mm, huh (meaning yes). I believe there's a little bit more to it with the stuff in your bag, but it doesn't change anything.

A: You think there's more too it?

Q: To be honest with you it would shock me if you told me you were actually planning on initially killing her, and then you realized that, that was a bad idea. You decided not to do that, that it would just be best to just talk to her.

A: I never ever planned (inaudible). (Inaudible) did not (inaudible).

Q: Well, I don't know you well enough to say yeh or nay, but...


A: (Inaudible) idea of (inaudible). She (inaudible) security to get to what I was looking for (inaudible). (Inaudible) actually, you look at me that way and there is no way I didn't have it.

Q: You were just gonna' scare her into thinking that you were...to get her to talk to you.

A: [REDACTED]

Q: Okay. Are you going to take me to your car?

 A: Yes.


Q: Okay.

A: Do you think they've called by now?

Q: I don't know, I'll check. Have a seat and we're gonna' see if we can get that all set up real quick.

(Tape 4)

Q: Why don't you want to tell me where the car is?

 A: I know, I'm gonna' tell you. I'm just trying to think if there's anything that I need to tell you before you get there. I don't want, I don't want any surprises.

Q: Okay. First tell me where the car is.

A: Are you gonna' stay right there?

Q: I'm gonna' have to walk out, but I'm gonna' be walking back in, and you're gonna' stay right there. I told you I wasn't gonna' just dump you off and I am a man of my word. We still have some things to talk about.

A: Okay. I know, you said that you're a man of your word. I know there was some discussion about her, about November. You didn't tell me that.

Q: O.K.. She told me they met in November. Um. Pretty much that was it. She told me she knew of you, and you guys worked together. That was all between you and him. She did not mention anything about a relationship. She did not make any reference about a relationship.

A: She didn't mention a relationship?

Q: No.

A: What's that?

Q: Because, she said that you worked with each other. It was something I probably wrote down. It's a question. If you were looking at this pack, that's probably what it was. O.K. that was something I was trying to find out from you.

A: Okay.

Q: Actually, I talked to him without her in the room.

A: He's here?

Q: No. (Inaudible). He's pretty much told me the same things you have except, he had a, he's made it more like it's a work relationship than anything.

A: So, he doesn't want to get me into any more trouble.

Q: And well, I'm going to indicate that both she and he indicated it was a work relationship only. If you're telling me (interrupted).

A: It appears to me that that's what she believes.

Q: Mm, huh (meaning yes). And if you're telling me, and if you're telling me that to protect his career, then it's fact, that's, that's something I can, I can state. And according to the two of them, it's a fact. You don't believe you were spending too much time on a personal level with the, so now I've got three people saying that it was just a work relationship, although you wanted it to be more.

A: What if (Inaudible).

Q: Now, where's your car?

A: I'm going to tell you .

(Ofc. Ryan steps into the room and says: In the Blue lot nothing appears.

Q: The time is right now.

A: O.K. I am . Let me make clear I understand what they are saying about wanting more (Inaudible).

Q: Go ahead.

A: I have some emails that, that disagree with that.

Q: From his computer?

A: Yes

Q: Did you have his password?

A: Yes.

Q: Okay. That's how you knew.

A: No, that's not how I knew, I, I, it was not anything different.

Q: (Inaudible) You need the emails verifying he was telling truth.

A: It, yes, it was nothing more different than what he had told you. There is no indication of what I was trying to find out about the other stuff... and... the phrase just a work relationship. I'm sure you can understand at this point that is something you say if every one else in the office is a (inaudible).

Q: I understand that they (inaudible).

A: (Inaudible) it's not just (inaudible).

Q: I, I believe what you tell me, he has every reason to tell me lies you don't.

A: Its important, whether it's me being this deranged person that is over interpreting things, or that my (inaudible).

Q: I can validate the assessment in the fact that, all right, it fits as to what happened tonight. Um, and to this point. And the reason I can say that is because you don't really have anything to loose. He and she have a lot to loose.

A: Like what?

Q: Well, she's a commander, I believe, or he's a commander? There both in the military, how many officials are in the military. That in of itself is something at risk for them, okay. You don't benefit by telling me anything that's not the truth right now.

A: I guess, I'm trying to figure out if there is any way that, I can minimize the impact to all three of us.

Q: I'm working on that. I, I understand that this is very delicate in nature just based upon

the position that the three of you hold. okay. And I can tell you that, that it's not my position as a human being to embarrass anybody, or allow anybody to be embarrassed.

A: I, I also... It's important.. I'll be at , after going off on this that I completely misinterpreted what wasn't there, and what was never there and what was not said to me. But I don't want to 'cause the trouble that I am now in that I don't want it to make my case first worse either.

Q: I understand.

A: Well, he's not being accurate that he told you that.

Q: And that's gonna' reflect upon him.

A: But I don't.

Q: Not through anything you and I have done per-say, okay. Let, hold on a second. I'm running out of time. My boss is ready to walk in here, and ask me where this car is, okay. I've got to provide him with some answer. Are you not gonna' tell me where you parked and then we can continue.

A: O.K., Do I need an attorney?

Q: That's the decision you have to make. You are an educated woman, very intelligent woman. I cannot give you any advice.

A: What would you do?

Q: Um, I, I have to, I will get in trouble if I do give advice, okay. I can't even switch shoes, okay.

A: O.K., Um.

Q: I can tell you that I see some, some issues with you personally that I think can be taken care of , that will help make things better for you. And I will be more than happy to recommend to the State Attorney's office and when you get an attorney as well. Because I really think that, that will make all the difference in the world, in a positive way. But, I need to know where the car is right now.

A: So, I'm going to court and have a trial?

## STATEMENT OF

Q: That's up to you. You have many, many options. Actually you don't have many options. You have a few options. Um, you'll be given the ability to... if you don't bond out right away you'll have what's known as an initial appearance in about 24 to 36 hours. There you will be given the ability to plead guilty, not guilty, or not contest. If you plead guilty, the judge may release you and provided a later date for sentencing, or may sentence you there. If you plead no contest the same thing may occur. If you plead not guilty then that gives you time to get a lawyer who will start doing all the research in the case, and discuss with the State Attorney's office whether or not there's, there's gonna' be a trial. Then your attorney will go ahead and advise you on what's gonna' be best for your case and if you decide to go to a trial you can do one or two things, have a jury trial, or you can have a non-jury trial. And then all that's something you're going to need about with your lawyer can answer those questions. So, there are ways to keep this out of court. Your attorney will understand what those, those uh, options are and can explain them too. Um, (inaudible). I can't help you

A: Whether or not... You mentioned that in the emotional response, of course she was in a position to do that also. I understand even if she changed her mind, that there would still be action.

Q: That's up to the State Attorney's office.

A: But, but um, There is possible some other outcome?

Q: Yeah. It's possible. Now, where's your car? Want something to eat?

A: No, thank you.

Q: Can I get you some crackers, or pretzels, or something? You want to try that?

A: (Inaudible).

Q: Okay.

A: There is no way to not call security?

Q: I'll look into see if I don't have to notify security. I can't make you any promises. Eventually they will find out though. They do continual background checks on you. Am I correct?

A: I don't know.

Q: But then the question comes up, is it worse to live and find out, or is it best to tell them now?

A: Oh, I wouldn't I, I, have to put it down I'm just thinking about (inaudible).

Q: I will look into trying to avoid doing that. That's, that's the best I can do right now.

A: You don't think so?

Q: I don't know. I may have overlooked a clause, or I could probably get approval from somebody in my chain of command to ah, over ride that.

A: Who has already been notified after you, and the two of them?

Q: The two of them has been notified. Um, my chain of command has been notified and the FBI has been notified.

A: The FBI? For what?

Q: You're part of a crime that involves Federal employees. I haven't given any names. I just told them that there's two NASA employees were in the office and I was interviewing them over an incident. So, they don't know who it is right now. Not to mention he is in Miami working the Super Bowl so.

A: But don't.. If they're wondering details, don't you (Interrupted).

Q: Knowing my buddy, he's just leaving it up to me to work with. This way I can say I notified the FBI and everything is O.K. It's more of a CYA for me than anything else. There's no official notification or any thing.

A: Why did you have to notify them then?

Q: Well, one is this is Federal property. If I don't notify, if there's an incident of this magnitude on Federal property, I'm gonna' get fired. So, my buddy and I have a working relationship. We understand each others thingamabob and we work within those parameters, okay?

A: Is there any possible way I could go back to work tomorrow (inaudible)?

## STATEMENT OF

Q: Don't worry about it

A: you just said (Inaudible).

Q: Well, once you tell him. I'm not gonna' prevent you from going back to work. I don't see any reason why you can't go back to work. I just, from what you've told me, repercussions will be severe, knowing NASA. (Inaudible) kicked out of the military.

A: Whispering (Inaudible).

Q: I doubt it, you're a captain in the military. And trust me as many captains that get in trouble and their still captains?

A: Not like this.

Q: You'd be surprised. You're not the only captain that has ever been in trouble like this. In the history of the Navy, I promise you, you're on a very long list of captains. Trust me, I grew up in the Marine Corp, I've seen, I've seen a lot. Now, (interrupted).

A: (Inaudible). With... Do... Can I write this down on a piece of paper.

Q: Okay.

A: (Inaudible).

Q: (Inaudible). Can I see were the car is?

A: (Inaudible). I wrote it down, you will get it either way. I just want an answer.

Q: (Inaudible).

A: (Inaudible).

Q: What do you need with this?

A: I don't. Nothing that is (inaudible).

Q: It's brand new. But you were holding this bag, when you went up to the car.

## STATEMENT OF

A: (inaudible) it's sitting in there (inaudible).

Q: But you were holding it so it's very accessible. I mean, why would you need this hammer?

A: It don't need any of it. I told you.

Q: What would this be for?

A: Exercise band.

Q: Lisa, (interrupted).

A: That is (interrupted).

Q: ...you have an exercise band with a hammer, with the black gloves, with this knife, with this garbage bag and all the cash that you had in here. I mean, really. What's with all this stuff. I mean, this is an expensive knife, brand spanking new.

A: It wasn't very much. I didn't have any of that out.

Q: It doesn't matter if you had it out, or not. You had it in your hand.

A: I didn't have it in my hand, I didn't.

Q: So, where did you put it.

A: All that stuff was just sitting in there.

Q: Okay. This bag was in your hand.

A: [REDACTED]

Q: Okay. So, you had access to this, as a matter of fact at any time you could use this hammer to break out the window to get in the car, couldn't you?

A: Well, I guess if I had thought of that (interrupted).

STATEMENT OF

Q: Or maybe hit her over the head and try and kill her?

A: No, no, no, no.

Q: I mean, this would be great for strangulating somebody, or pick-up the parts and suffocating somebody,...you know? You see where I'm going with this 'cause this doesn't look good. There was more to your plan than what you told me. You've got the makeup on here. You have it's brand new, it's not like you're using it.

A: (Inaudible).

Q: So, what's the deal? It's not like you have clothes in there and you're traveling. You have that hammer, and knife, rubber hosing.

A:

Q: Okay. So, you decided to nix that idea about siphoning the gas.

A: I didn't (interrupted).

Q: What's with the hammer?

A: The other stuff, [REDACTED] all this whole thing of finding, what, what could be this whole, get her to talk to me thing, and you know. Like okay, what looks scary and I and as you could see me I inquired any number of things without any plans, or using any of them. And I'm have decided (inaudible). I didn't know, I didn't have a plan I just wanted to be, I really, really wanted her to talk to me. I wanted (interrupted).

Q: Alright. Are you gonna' give me where the truck, or where the car is?

A: Yes. But would you talk to me now, you don't believe me anymore.

Q: No, not really. Buying a hammer like that, a knife like that.

A: I had no desire or intentions to actually...

Q: To what?

A: ...'cause her to do anything that would (inaudible).

Q: So, basically your intent was just to scare the living shit out of her basically.

A: At some point when I was getting those things (inaudible) (inaudible), I mean, I just really (inaudible) a plan, I wouldn't, I wouldn't of (inaudible). I didn't know what I wanted to do. Yes I do, I know what I wanted to do, I wanted her to talk to me. And I wanted if she, if I, I got in the car and she said, "No, I'm not talking to you" then I

Q: Why don't you just say you wanted to scare her to talk to you 'cause that's what the truth is.

A: [REDACTED]

Q: But

A: ...it seems like if it would make sense, but obviously that didn't make sense.

Q: This whole thing doesn't make sense. I mean, really none of it makes sense, does it?

A: No, of course not. This is...

Q: Insane.

A: is it?

Q: Yes, it is, very. Okay. This isn't gonna' be let's make a deal, okay. You're gonna' let me know where the car is, and when I get a call I'll let you know what legal says. Or, you're not and I'm gonna' go find it.

A: (Inaudible) there's stuff that's in there um, that you know I'm going through the process of getting divorce paperwork, and examples that were provided to me are in the car, and you can guess who they were from.

Q: Okay. Um, do I have your permission to go in your car, and search your car? I'll bring you with me so that if you change your mind you're able to make sure that I didn't change your mind.

A: Are you changing what you're accusing me of?

Q: No. I'm still charging you with aggravated stalking.

## STATEMENT OF

A: That's it?

Q: Mm, battery and theft is a lesser crime for the pepper spray.

A: What's Aggravated Stalking (Inaudible).

Q: That's a felony where as the battery is a misdemeanor. That gives the Assistant State Attorney bargaining room if they want to negotiate a plea deal.

A: But it's the same (Inaudible)?

Q: Sort of kind of. The stalking is everything that led up to tonight, including (inaudible), the battery is the actual pepper spray. So, it's not a double jeopardy, but it gives the Assistant State Attorney some room to plea things down if that's, if that's what is agreed upon by everybody.

## SIDE B STARTS HERE.

A: Um.. I knew she was coming to visit, I knew when she was going back. The earliest opportunity I could place, where I could.. Knew to talk to her. It, it I don't know exactly, I don't know for sure that um, I (inaudible) her, I mean, I didn't, I never met her. I mean, I, I was going off a description, you know.

Q: Okay. How did you know she was coming here?

A: Because ...

Q: Mm, huh (meaning yes).

A: Because I knew, I mean, I knew she lived at Cape Canaveral he told me that. He told me that before coming here.

Q: Okay. How did you know she was coming to Orlando this morning?

A: I knew when she was leaving. I mean, actually that whole weekend originally was suppose to be like a bike ride, or something and it turned into Super Bowl, then it got... O.K. that plan didn't...that plan got all...All, all that meant that, that she was leaving at 5:30, that's not hard to find out.

Q: So, initially you had plans for him, for the weekend.

A: Uh, for Saturday, It was never confirmed. It was discussed that we would go on a bike ride Saturday morning. It probably would have been. I don't know there were four bike rides that month.

Q: Okay. Are those intimate times for you?

A: Bike rides?

Q: Yeah.

A: Those aren't intimate.

Q: Okay.

A: Personal? I mean...

Q: What what's the difference between personal and intimate?

A: I guess the same. Well,...affectionate (inaudible) bike ride.

Q: Okay. So, there personal between the two of you, at least for you.

A: I was told it was not just me.

Q: Okay. So, you have been (inaudible), or he's told you that there personal for him too?

A: He didn't. I think that you have this impression that I'm (inaudible) going (inaudible) direction in giving no input at all that, you know, I'm just wanted just something to happen. And that this is all my idea, and that he has no indications towards me (inaudible), is that what you were thinking?

Q: No. I told you what I was thinking earlier. I was thinking that the two of you were building on something, working on something. Some sparks are flying and she comes in and interrupts that. And he's giving you mixed signals. He's telling you that well, he's exclusively for her, but what he's showing you is you're, she's not exclusively, there's you too. And it's sending you mixed signals. That's what I think. What I'm trying to put together is finding out (interrupted).

A: But does she have any ideas about it.

## STATEMENT OF

Q: I would have to say no. Not because of anything she said, just from listening to her and, and listening to what you're telling me. 'Cause she hasn't told me a lot, but from the way she was telling me how she knew you.

A: Well, I know that they met in November. And I was told about her at the beginning of the year. I don't think she has any more information, other than at one point, I don't, it...I thought it was possible that she believed or believes that after that from the point that they met that (inaudible) whatever closeness there was beyond a person to work with I was or had been in the past at that point, I think that's possible.

Q: Okay.

A: And I don't think that that's, I think this like, like I told you before I think people should make that decision about their relationship that they want to have.

Q: Alright. And you want to give her the information though.

A: I want her to be aware, if that's the case or not, and I had not decided whether I needed to be the one to give it to her, or to go back and say, okay, it's clear that she doesn't understand, or wasn't told, and I think that you ought to do that. And I don't know, I don't know my inclinations that, that might be better, but um, I thought it was important that everybody know (interrupted).

Q: Everybody's on the same page?

A: Yeah.

Q: Okay. Let me ask you this, you printed these maps on January 23 and 25<sup>th</sup>. The information about the airport, the dates are stamped at the bottom of the page?

A: Well, that is because I knew that she was coming here. I, I was (inaudible).

Q: So, was it on the 23<sup>rd</sup> that he told you, or was it before that?

A: What hat she was coming here?

Q: Mm, huh (meaning yes).

A: I don't remember the exact date. If, if it was in that vicinity, okay.

Q: Alright. Here's, here's what I'm gonna' do.

A: Okay.

Q: I'm gonna' charge you with aggravated stalking and that means that you were doing something that was harassing to another person. And somebody, some type of force was used being the spray. It's not car jacking, it's not robbery, it's not (inaudible) homicide, that's the good news, okay. Nine times out of ten probation, but I'm going to highly recommend that you get counseling. You have a lot of stuff bottled up inside of you girl.

A: yea.. I know. I need to see her.

Q: You're not going to be able to see her. You don't need to call her, you don't need to see her, you don't need to write her.

A: I want to.

Q: you need to dump him out of your head. You're how old, 39?

A: Almost.

Q: Happy birthday.

A: (Inaudible).

Q: What is it? Girl, you're just startin' over. You know what this isn't the end. When is your birthday?

A: (Inaudible) tenth.

Q: Social security number?

A: (provides Social Security Number). I was trying to fix I wanted to talk to her(inaudible).

Q: Doesn't matter what you were about to tell her. (Inaudible).

A: (Inaudible).

Q: (Inaudible), I promise you. Nothing you say is gonna' change her mind.

## STATEMENT OF

A: About how she felt?

Q: About anything concerning him. As far as she would have seen you (inaudible) if you had talked to her all she was going to see, was some crazy lade drove all the way here from Houston, and that's not what she needs to see. She needs to see that you're a very intelligent woman, who has had a series of hard times. I am willing to bet that .

A: Well (Inaudible). I mean, at that time (inaudible). I got full support from the person we are talking about .

Q: Sure, but you didn't have to deal with any of the other stuff you're dealing with, with your husband, and your family and marriage.

A: That's been going on for years.

Q: So, that's years of that you've been having to deal with that.

A: Yeah. I mean it wasn't a new development .

Q: No. We're just talking about it was nice escape that was the most peace you had felt in a long time.

A: I had more sleep up there, than down here.

Q: Mm, huh (meaning yes).

A: I didn't feel like I was in space. It was...

Q: Well, you were working, but there's times when you are more relaxed at work than when you're at home.

A: Yeah. That would .

Q: Which makes you feel slighted because the sharing was occurring while (interrupted).

A: I, I, (interrupted).

Q: ...while you were working.

A: While I was working?

Q: Actually, I'm sorry (inaudible).

A: No, no.

Q: (Inaudible).

A: Eventually I tried to be supportive, so, yea. There was a period of time were I didn't know things had changed. They weren't changed as far as um, what was coming towards me. Um, maybe a slight amount. But of course there is a period of time when you find out you didn't know what was going on, of course that hurt.

Q: Mm, huh (meaning yes).

A: But from that point forward it's like, okay, you know what the situation is, so from here on you make a decision on whether it's the right thing, or not. And um, yes even though there's, that there's another person with (inaudible) um, everything else that we've always had done, we were still doing together.

Q: Which gives you the signals?

A: Which gives the signals of um, (interrupted).

Q: Give you mixed signals

A: If there are signals still there it's just that um, yes, they are now also clearly some for another person um, (interrupted).

Q: Still gives you mixed signals

A: I was, I wasn't...I think it's possible that I would be O.K. with that, but it's important to me that, I mean, why only be honest with me, why not be honest with her also. Does that make sense?

Q: Mm, huh (meaning yes).

A: If, if, if that's the case then yes, at some point you gotta' reassess. You can't go along, with this threesome you know, or however how many people would, you know, go out some point. Eventually, everybody knows it's probably gonna' fall apart at some point. But if some people don't know, then that's not the right kind of situation. I very much wanted to set it right and in order to do that I need to know whether that

it needed to be done. Because if I could get a straightforward answer from the person who knows, or doesn't. Where if I were to say hey have had this discussion with her. I don't know. (Inaudible) I mean, yeah, yeah the answer could have been well, no we haven't, or yes depending is that the truth. I didn't know if I asked the questions what (inaudible) what could the answer would be. Um, I didn't know if she thought well, if he told her that well give her away, you know. But I, it was important to know at least for me if she did or not. I don't, I had not decided well, if, if she doesn't then I'm gonna' tell her, or that I'm gonna' make him tell her, whatever. I just needed to know if she was aware, you know, that there was... He picked me up from the Airport two weeks ago. I mean, I mean, you don't just do that for anybody.

Q: Mm, huh (meaning yes). He's giving you mixed signals. He showing you that it's more than just friendship, but then he's telling that it's just friendship, and actions speak louder than words.

A: Yea. If what came across was o.k., this has to be friendship, because of the position we are in, that's what it has to look like. And there's somebody else it doesn't have to look like that, and I think obviously that person is not in a position to do that.

Q: Mm, huh (meaning yes).

A: If you know there is feelings there, not that you imagined them, but you've..., because he's also been told then, I guess you can see that mixed signals start that could also be seen as um, signals that can't, that aren't available to be shared with others. Does it make sense?

Q: Yeah.

A: And (interrupted).

Q: would really want to call him and tell him?

A: No. apparently that was wrong (Inaudible) you know. Hey oh gosh (inaudible) some one else there and (interrupted).

Q: (Inaudible).

A: But it was not a matter of being right here. It's just, okay, here's this other person and yet this particular aspect of the relationship. The intent is to be (interrupted).

Q: Mm, huh (meaning yes).

## STATEMENT OF

A: ...with her that um, but the rest of the um, friendship, or relationship, or closeness, or whatever all still occurs as frequently as reasonable. And some things you see clearly. I was in a position of thinking it's exclusive if somebody else is spending that kind of time with somebody in those sort of things, that doesn't fit.

Q: Mm, huh (meaning yes)

A: Which is okay, if everybody is okay with that for their own lives.

Q: Somebody has to make a choice.

A: Yeah, At, at some, at some point if everyone all knows about all that and their all okay with it, you don't have to make a choice if everyone's okay. But, at some point I assume that that's not okay with everybody, and then, then yeah, there's choices to make. And I had no intention of forcing choices that was not at all what I was trying to do. There was no, it was not like you know, oh go away or I'm gonna' hurt you. That, that, it was not at all like that. That's stupid, you can't get, you can't, I mean, all that does is, you know, put you out of the picture. I just want the, the information, and figure out if she didn't have information, how should she get it. I didn't know if she had it. I mean, I really, yes, very, very much felt like I needed to know that and that's really, that is the complete honest, truthful, dry version behind everything (inaudible).

Q: Feel better?

A: Yeah, as far as coming in here, yeah, like whatever it was.

Q: Do you feel better?

A: Yeah. (Inaudible).

Q: (Inaudible).

## STATEMENT OF

A: (Inaudible). And I'm trying to figure out, you know, if I could go see her. I don't know exactly where she's working, exactly where I couldn't even find out um, you know, initially, you know, where exactly she is in the data base. I couldn't find her on the Internet, anyways, I had to guess for that. I didn't know if it was right because, I couldn't find it. I, I, Like, I had to, had to, I didn't know if it was right because I couldn't find (inaudible) initially. Um, even if I did that I didn't know, I didn't just like um,...I just on the Internet like, you know, kind of search and find (inaudible). I didn't know if it was the right one, there's a bunch of people with the same name. I didn't know if it was the right place. I couldn't find the phone number and I just didn't know where, or when and I didn't have all these variables. And, and then when I found out in that place I knew I could be and meet her that, that she, that okay, that it's just this thing. I, it was just like okay, go do this. It was the strangest thing in the horizon, and I just really needed to talk to her. And I know it sounds like I was obviously desperately thinking of ways to make her talk to me.

Q: Mm, huh (meaning yes).

A: Um, which I hate to talk about logic and I um,...logically concluded um, at least certain things, most of the various things, that um, I guess, I didn't think. None of it makes sense, does it? I, I don't know why, I, I shouldn't of even, [REDACTED] (inaudible). I followed her to the car, [REDACTED] so she would let me sit in the car and talk with her, and then of course, as I responded to her, she got scared and she started to roll up her window. [REDACTED] and it was like, you know, that was so, I'm like (inaudible) maybe I, I didn't, I didn't know if it would stop her. I just wanted her to sit still, and of course, you know, at that point, you think logically about oh, shit talk to me now, of course not. That was stupid. But she was driving off anyway. Like this is my only chance, I'm never gonna' see her again. I'm never gonna' find her again, you know. I have a possible (inaudible) there was like five people and you know, I picked one that, you know, might have been the right one. And I don't know if it was and I knew if it was I didn't know if there would be a right time and a place. I just went, it's a long way to come, you know, that you might find someone.

Q: Mm, huh (meaning yes).

A: And even with this I mean, I, you know, I could of easily missed her and if not known

it was her, or whatever. So, if it's, you know, not, [REDACTED] it's like it would only be ten times worse after that. I didn't figure I would find another opportunity to talk to her in person.

Q: Let me ask you this? (Inaudible). Um, (interrupted).

A: It was important for me to be able to talk to her. I, I tried (interrupted).

Q: You saw her get on the bus to go to the parking lot, you get on the bus with her. The driver didn't ask you where you were going, why?

A: Why didn't he ask me?

Q: Did you already know where you were going?

A: He already knew? I don't see how it's relevant.

Q: You hadn't ridden the bus out there before she got here?

A: Yes, I did, but that, it wasn't the same bus driver.

Q: Different bus driver?

A: I assumed it was. I didn't look at him.

Q: So, why did you ride the bus out to the blue lot?

A: Because that was my best guess about where she was. I didn't, I had no idea where her car was located. In fact I still don't, I still don't know what kind it was, what color it was, what the license plate is. It's a psychological (inaudible).

Q: So, you just waited for her to arrive here, and then follow her to her car.

A: Yeah.

Q: Oh, okay. Where did you park your car at? There's stuff in there that shouldn't be there, isn't there?

A: (Inaudible) not weapons, or anything.

Q: No. But there's stuff that's not gonna' look very good, isn't there?

STATEMENT OF

A: I don't know I was, I mean , I didn't know.

A: I brought a sleeping bag and I didn't know if I'd be able to find a place to stay. I didn't.

Q: Where is the car?
